This short supply request is filed on behalf of our client, Fishman & Tobin, a designer, manufacturer, and importer of premier children's clothing for over 90 years, with global headquarters at 625 Ridge Pike Building E, Conshohocken, PA. The company employs over 440 people in the United States.

Pursuant to Section 203(o)(4) of the Dominican Republic-Central America-United States Free Trade Agreement ("CAFTA-DR") Implementation Act and the Modified Procedures published in the Federal Register Notice of September 12, 2008, by the Committee for the Implementation of Textile Agreements ("CITA"), we hereby request a determination that certain woven fabrics of polyester, rayon and wool yarns, classifiable in subheadings 5515.11.00, 5515.19.00, 5516.92.00, and/or 5516.93.00, Harmonized Tariff Schedule of the United States ("HTSUS"), be added to the list of fabrics, yarns and fibers not available in commercial quantities in a timely manner in the CAFTA-DR countries, set forth in Annex 3.25 of the Agreement and incorporated in Note 20(a) of Chapter 98, Subchapter XXII, HTSUS.

Fishman & Tobin is filing this request because the company has found it impossible to purchase such fabric in the United States, the CAFTA-DR region, or even in Mexico. The company has owned and operated a factory in Santiago, Dominican Republic, for over 20 years and has approximately 2000 employees working at the facility.

1. Detailed Product Information

The subject fabric is woven of polyester, rayon and wool staple fiber yarns. A complete description of the fabric is set forth below. Fishman & Tobin utilizes this fabric for the production primarily of men's and boys' dress suits, jackets and pants. The instant fabric has the content, characteristics, hand feel, and price range that render it perfectly suitable for the dresswear trade.

The fabric is classifiable in subheading 5515.11.00, 5515.19.00, 5516.92.00, and/or 5516.93.00, HTSUS, depending on the percentages of polyester and rayon staple fibers. We note that the fabric description provides ranges of content, counts, etc., so as to ensure that variances in fabric construction will not preclude the ability to enter the finished garments under CAFTA-DR, and to avoid having to submit multiple requests for short supply designation. The specifications set forth below, including all of the ranges, are identical to those expressed in our due diligence letters.

 - Warp Spun yarn either plied or single of various sizes, of intimately blended¹ Rayon & Polyester staple fibers

Fishman & Tobin has a longstanding knowledge of DR-CAFTA fabric suppliers, given the company's 90-plus years of working in the boys' dresswear business, which focuses heavily on this hemisphere, sourcing from many mills in the region. The company has sought and obtained short supply status for seven other similar dresswear fabrics, six of them in the past year. The list of mills Fishman & Tobin contacted for the subject petition was compiled from the company's working knowledge of the mills of the DR-CAFTA region and the mills contacted for the company's prior petitions, including those that expressed interest in producing other dresswear fabrics for the company. Fishman & Tobin also contacted two major textile associations representing mills in the United States. Included with the correspondence to the mills and associations were the detailed description provided above, along with a swatch of the material. Most of the mills and members of the associations did not express an interest in supplying this fabric. In fact, several mills affirmatively stated that they would be unable to supply the requested fabric in the quantity and time frame provided in our request. For those who did not reply to its initial request, Fishman & Tobin sent follow-up letters, with the same result.

It is evident from the results of Fishman & Tobin's inquiries outlined above that the subject fabric is not available from mills located in the CAFTA-DR region in the quantities required and within the given time frame. The mills and associations either responded that they could not supply or failed to respond entirely.

4. Substitutable Products

Fishman & Tobin has been unable to obtain any fabric produced in the CAFTA-DR region that would be an adequate substitute for the fabric which is the subject of this request. As stated above, this fabric is used to produce men's and boys' dress suits, jackets and pants, and is particularly suited for that purpose. This fabric is unique for several reasons. It is important that the polyester and rayon fibers are staple and intimately blended with each other or the wool, to achieve the body and hand necessary to translate into a suit jacket and dress pant. The staple polyester adds strength to the wool fibers in the intimately blended yarns and the rayon fibers aid in the drape and hand. This fabric is destined for constructed suit and suit separates in both men's and boys' in a better mid-tier market. The wool elevates the perceived value of the fabric above a regular polyester/rayon blended suiting and resonates with the customer as a better quality fabric, thereby allowing Fishman & Tobin to give its customers great value and a better quality suit at that price point. Fishman & Tobin's customers require this special blend to have the quality, drapability, and hand that this fabric provides, and for which there is nothing comparable available from regional mills.

5. Conclusion

In view of the above, we hereby request a determination that the Polyester/Rayon/Wool fabric is not available in commercial quantities in a timely manner from mills that produce fabric in the CAFTA-DR region. We therefore request that CITA add this fabric to the list of fabrics, yarns and fibers in Annex 3.25 of the Agreement and incorporated in Note 20(a) of Chapter 98, Subchapter XXII, HTSUS.
