Re: Petition Regarding the Commercial Availability of Certain Cotton/ Polyester Fleece Fabrics (#2)

Dear Chairman:

On behalf of Garan Manufacturing Corp., of Starkville, MS, we hereby submit this request for a finding of commercial non-availability pursuant to the provisions of Section 203(o)(4) of the Dominican Republic-Central America-United States Free Trade Agreement (“the Agreement”) Implementation Act and CITA Final Procedures for implementing Section 203(o)(4) contained in CITA’s Federal Register notices of March 15, 2007 and the Modifications to Procedures of September 12, 2008 (hereinafter “Procedures”) with respect to certain fabric, described in the Annex attached to this request, to be used in the manufacture of apparel in a DR-CAFTA country. By means of this letter, we request that CITA place the subject product described in the Annex on the list in Annex 3.25 of the Agreement because the fabrics are not available in commercial quantities in a timely manner from a supplier in the CAFTA-DR countries.

(1) Detailed Product Information

The Annex provides in detail: fiber content, construction, yarn size, and finishing processes; and the classification of the product under the HTSUS. The fabrics in question are cotton/polyester 20 gauge three-thread fleece classifiable under HTSUS subheading 6001.21.

The product specifications, including, fiber content, construction, yarn size, and finishing processes are reasonable and stated in terms of accepted terminology and standards.

We note that the subject fabric is similar to an existing item contained in Annex 3.25, namely File Number 25.2007.07.06.Fabric.ST&RforGaranMfg. The differences between the existing specifications and those in the subject fabric relate to additional tolerances for fiber content and yarn denier, as well as the removal of the requirement that the cotton in the fleece yarn be combed. .

These standards and specifications were explained to all potential suppliers.

Timing was expressed as the annually quantity being supplied quarterly.

(2) Quantity

Garan requires 181,439 – 1,133,993 kilograms (400,000 – 2,500,000 pounds) each season – January – June of each calendar year.

(3) Due Diligence

(i) Generally:

The following is a summary of our contacts and due diligence that demonstrates Garan's legitimate intent, and good faith and reasonable efforts to obtain the subject fabrics from DR-CAFTA suppliers.

We made initial contacts with all potential suppliers to locate sources for the subject fabrics, as well as the industry associations in all DR-CAFTA countries. Only one company expressed an initial interest or capability to produce the subject fabric, but subsequently determined that they could not produce the fabric.

The following firms and associations were contacted and asked if they or their members could supply the subject fabric. Contact and communication was made by various methods: email, courier service, U.S. Express mail, and teleconferencing.

(ii) Identification of CAFTA-DR suppliers:

As part of our due diligence, we contacted the trade associations representing the DR-CAFTA countries' textile industries. We also contacted numerous individual companies throughout the DR-CAFTA region that based upon our inquiries and experience could conceivably produce the fabrics in question. To the best of its knowledge and ability, Garan identified and contacted any regional supplier that might have the capability to produce the subject fabric. As the foregoing explains, these efforts to identify CAFTA-DR suppliers were reasonable in light of the product at issue.

(iii) Use of Third Parties and Business-to-Business Contact:

We made all initial contacts with potential suppliers. Once an indication of interest to supply was received all contacts thereafter were made by Garan and were made at the level appropriate to communicate information on the fabrics needed, the specifications and standards, and the reason for those standards. Garan was represented at the highest level of the company.

(iv) Description of the Subject Product:

The Annex was provided to all potential suppliers and represents reasonable product specifications, including fiber content, yarn size and finishing processes expressed in accepted terminology and standards. The Annex describes with specificity the fabrics needed by Garan,

(v) Provision of Samples

No dialogue with any prospective DR-CAFTA supplier advanced sufficiently to warrant the exchange of samples.

(vi) Substitutability of Products:

No prospective DR-CAFTA supplier suggested the use of an alternative or substitutable fabric.

(4) Substitutable Products

It is absolutely critical that the fabric in question meet the stated performance criteria. A fabric that cannot match the shrinkage, torque and flammability requirements is simply unusable to Garan and its customer and therefore is not substitutable.

Garan is unaware of any supplier that produces a substitutable product in the DR-CAFTA countries, and did not receive an assertion that a conforming fabric could be produced that was substitutable for the fabrics requested.

Circular Knit Three End Fleece - #2

HTS Subheading: 6001.21

Fiber Content: 67-73% cotton / 27-33% polyester

Average Yarn Number:

Face yarn - 100% combed cotton; 47/1 to 58/1 metric (28/1 to 34/1)

Tie yarn - 100% filament polyester; 167-196 metric/48 filaments (46-54 denier / 48 filaments)

Fleece yarn – 57-63% cotton /37-43% polyester; 12/1 to 20/1 metric (7/1 to 12/1)

Gauge: 20

Weight: 271 to 300 grams per square meter (8.0 to 8.85 ounces per square yard)

Width :152 to 183 centimeters (60 to 72 inches)

Finish:(Piece) dyed; printed

In addition, the technical back must be heavily napped to produce a fabric thickness of not less than 4.5 millimeters, including the napped pile. The height of the pile is a requirement of the finished fabric. During processing, including rolling of the fabric, the actual height of the fabric, including the napping, may be less. Additionally, a portion of the fabric is brushed on the technical face to produce a sueded hand and appearance and a portion is treated with a stain release finish. Finally, the following performance criteria must be satisfied:

- Vertical and horizontal shrinkage must be less than 5%
- Torque may not exceed 4%
- All fabrics must have a Class 1 flammability rating
- For optimum fabric integrity and stitch definition, this fabric must be knit on machines whose number of yarn feeds is a multiple of 3.
