Re: Commercial Availability Request Under Section 203(o)(4) of the Dominican Republic-Central America-United States Free Trade Agreement Implementation Act

On behalf of Cintas Corporation ("Cintas"), and pursuant to Section 203(o)(4) of the Dominican Republic-Central America-United States Free Trade Agreement ("CAFTA-DR") Implementation Act and the Modified Final Procedures set forth in 73 Fed. Reg. 53200 (September 15, 2008) ("Final Procedures"), Sorini, Samet & Associates, LLC ("SS&A") requests that the fabric described herein ("subject fabric") be added to the list in Annex 3.25 of CAFTA-DR in an unrestricted quantity.

Russell Corporation ("Russell") of Alabama used to supply the subject fabric to Cintas, where it was manufactured into uniform apparel in Central America and then imported into the United States as an originating good under the rules of origin of CAFTA-DR. Russell notified Cintas that it is no longer taking orders.

With the Russell supply terminated, the subject fabric is not currently available in commercial quantities in a timely manner from a supplier in the CAFTA-DR countries. Cintas and SS&A made this determination after a thorough exploration of the market in CAFTA-DR countries in an attempt to secure the fabric from potential suppliers. It is following a good faith effort to secure the fabric that Cintas and SS&A submit this commercial availability request.

### **I. DETAILED PRODUCT DESCRIPTION**

All figures listed are in metric units:

## II. QUANTITY

Cintas requires [[\*\*\*]] to [[\*\*\*]] square meters per month.

## III. DUE DILIGENCE

Cintas received notification that Russell is not longer supplying the fabric. A copy of the notice is provided within Appendix I of the confidential version of this submission.

SS&A and Cintas made inquiries to potential suppliers of the subject fabric in the United States and the CAFTA-DR countries. The list of companies was compiled (A) through Cintas's experience doing business in the CAFTA-DR region, (B) through the 2008 Davison Salesman Blue Book, and (C) through the contact mechanisms of U.S. and Central American textile and apparel trade associations. These efforts did not result in identifying any parties that were able to supply the subject fabric in the time and quantities required by Cintas.

Two parties, Industrias Liztex (10) and Wade Manufacturing (12), responded to the due diligence inquiries with an interest to supply the subject fabric. Cintas contacted Liztex and Wade Manufacturing directly (April 20) to request information necessary to determine whether Liztex and Wade, respectively, had the capabilities to supply the subject fabric. Copies of the letters, in the form of email attachments, can be found in Appendix II of the confidential version of this submission. Cintas followed up on the contacts with Liztex and Wade, respectively, on two separate occasions (April 28 and May 13), but neither firm was responsive to Cintas's contacts.

Two parties, Mount Vernon Mills (9) and Swift Galey (8), informed SS&A and Cintas that while they were not able to supply the subject fabric, the companies had made respective offers to acquire the Russell operation and assume its production portfolio. Ultimately, Mount Vernon Mills ended communication regarding its potential acquisition of Russell, and Swift Galey informed Cintas that it was no longer proceeding with its potential acquisition of Russell.

The following information sets forth the firms and associations that were contacted with regard to whether they could supply the fabric within the specifications described in Section I of this submission. Confirmations of the contacts are provided in Appendix III of the confidential version of this submission. All communications were conducted via e-mail unless otherwise noted.


#### **IV. SUBSTITUTABLE PRODUCTS**

The subject fabric is a ring-spun, woven polyester/cotton blend, with a unique combination of finishing processes and chemistries, which are critical for the end-use of industrial, career and work uniforms. For the end-use described, other fabrics of different fibers, yarn types, thread counts, or weaves, and without the exact combination of spinning, weaving and finishing processes, cannot substitute the requested fabric. Cintas requires that the subject fabric meet the specifications outlined in Section I of this submission in order to achieve the proper life-cycle performance in the work setting as well as in repeated harsh commercial processing.
