> Re: Commercial Availability Request Certain Cotton/Polyester Three Thread Circular Knit Fleece Fabric

Dear Ms. Glas:

On behalf of Intradeco Apparel, Inc., 9500 Northwest 108th Avenue, Medley, Florida 33178 ("Intradeco"), and pursuant to Section 203 of the Dominican Republic-Central America-United States Free Trade Agreement ("CAFTA-DR") Implementation Act (19 U.S.C. § 4033(o)(4)) and the Committee for the Implementation of Textile Agreements' ("CITA's") Modified Final Procedures for Considering Requests Under the Commercial Availability Provision of CAFTA-DR (73 Fed. Reg. 53200 (Sept. 15, 2008)), we request that certain cotton/polyester three thread circular knit fleece fabric be added to the Annex 3.25 CAFTA-DR Short Supply List that is maintained on the Office of Textiles and Apparel website¹ and referenced at U.S. Note 20(a) to Chapter 98, Subchapter XXII, Harmonized Tariff Schedule of the United States ("HTSUS").

I. Detailed Product Information

The subject fabric is certain cotton/polyester three thread circular knit fleece fabric. The fabric has the following specifications, some of which are expressed in ranges:

Intradeco believes that the fabric specifications set forth above are already described at numbers 78 and 131 on the Annex 3.25 CAFTA-DR Short Supply List. Intradeco orders fabric according to the specifications in these existing designations, but fabric characteristics – especially constituent yarn size – often change as a result of production and finishing processes. Nonetheless, in determining whether apparel made with short supply fabric qualifies for preferential treatment under CAFTA-DR, U.S. Customs and Border Protection tests a finished garment in its condition as imported and tolerates no variation from the pre-production specifications. Thus, Intradeco requests that CITA add the above specifications to the Annex 3.25 CAFTA-DR Short Supply List solely to describe the finished fabric, as it may appear in tests of samples taken from finished garments, which could result when raw materials are purchased and fabric is produced according to specifications already on the Annex 3.25 CAFTA –DR Short Supply List.

II. Quantity

Intradeco requires 6 million pounds (approximately 10,541,000 square meters) of this fabric annually. Intradeco requires delivery of the fabric at a rate of approximately one million pounds (1,756,833 square meters) per month for six months each year, with deliveries beginning in March and completed by August.

III. Due Diligence

Before making this request, Intradeco made reasonable efforts to identify CAFTA-DR suppliers of the fabric that is the subject of this request. Having made these inquiries, Intradeco believes that the fabric is not available in commercial quantities in a timely manner from CAFTA-DR suppliers. A spreadsheet summarizing this due diligence is attached. (Attachment 1).

Because the subject fabric is so similar to the fabric described at number 131 on the Annex 3.25 CAFTA-DR Short Supply List, we began the due diligence by contacting each company that was contacted during the due diligence for that earlier proceeding.

Alston & Bird or Intradeco contacted each company at the email address and, where provided, physical mailing address listed in the short supply request that led to designation number 131. A copy of the letter sent to potential CAFTA-DR producers on November 8 is attached. (Attachment 2). We request confidential treatment of Attachments 2-5. Based on Intradeco's current knowledge of the industry, Intradeco also reached out to its contact at Textufil, even though Textufil was not contacted during the due diligence for the earlier proceeding.

To ensure that the inquiry reached any other potential producers that were not part of the earlier proceeding or otherwise known to Intradeco, Alston & Bird contacted the major U.S. and Central American textile trade associations by both email and U.S. Mail. Copies of the letters sent to these trade associations on November 7 and of any responses received from those associations are attached. (Attachment 3). At the suggestion of a CAFTA-DR company that received the inquiry through one of these associations, Alston & Bird subsequently sent inquiries to Antex Knitting Mills, Carolina Cotton Works, and Grupo Beta (Coral Knit). Additionally, Contempora Fabrics and Alcatextil learned of Intradeco's inquiry from trade associations or industry members, and Alston & Bird and Intradeco responded to these two companies' requests for additional information.

In some cases, our attempts to reach these companies failed. The spreadsheet at Attachment 1 indicates when mail or emails were returned as undeliverable. When we received notice of a failed email transmission, we consulted Davison's Textile Blue Book² for updated contact information or alternate email contacts. When companies were not listed in the Blue Book, we conducted a general web search for contact information. The spreadsheet at Attachment 1 describes the results of this research and our further outreach to companies by email or facsimile. As the spreadsheet also indicates, for a small number of companies, contact information was not available online. Often, however, websites that collect manifest data indicated that shipments from these companies stopped several years ago. In such cases, we made no further attempt to contact the companies.

Where we believed our letter was successfully delivered to a company or trade association by mail or email, but we had received no response, we made a second contact attempt on November 20. Some companies still did not respond, so we consulted the Blue Book and then searched the web for companies not listed in the Blue Book to find telephone numbers for further follow up. Where phone numbers were available, we made a third attempt to contact the companies on December 18 and 21.

Significantly, pursuant to the requirement in CITA's Modified Final Procedures that, "[o]nce interest is expressed between requestors and CAFTA-DR suppliers, subsequent communications should be conducted by appropriate officials of the requestor and CAFTA-DR supplier based on normal business practice," Intradeco was directly involved in business-to-business communication with any company that indicated that it

might be able to produce the requested fabric. Seven companies – Monte Textile, Elcatex, Clover Knits, Antex Knitting Mills, Carolina Cotton Works, Contempora Fabrics, and Alcatextil – initially expressed an interest in supplying the fabric. Following further discussions with Intradeco, however, each company confirmed in writing that it was not able to supply or was not interested in supplying the requested fabric at this time. Moreover, because of Intradeco's knowledge of and contacts within two companies, the first outreach to both Textufil and Pettenati occurred at the business-to-business level. Both companies also confirmed in writing that they would not offer to supply the fabric at this time.

All of this due diligence is documented in the attachments to this letter. As noted above, Alston & Bird's letters to producers and trade associations are included at Attachments 2 and 3. Evidence of Alston & Bird's November 8 initial email outreach to potential producers and its November 20 follow up email outreach is included at Attachment 4.³ Records of failed email transmissions, correspondence to alternate email addresses, facsimile correspondence, results of Blue Book and internet research, memoranda describing telephone calls, and correspondence received from potential producers are included at Attachment 5. As these records confirm, the requested fabric is unavailable from CAFTA-DR producers.

IV. Substitutable Products

Intradeco has developed its fabric specifications to meet its customer's particular requirements. The specifications provided above are expressed in ranges, to give producers as much flexibility as possible, but Intradeco is unaware of any fabric outside these ranges that is substitutable for the requested fabric. Fleece other than three thread fleece, fleece not made on 21 gauge machines, or fleece of any other weight or fiber content would not permit Intradeco to meet the demands of its customer.

V. Conclusion

Because the attached documentation confirms that the cotton/polyester three thread circular knit fleece fabric that Intradeco seeks is not available in commercial quantities in a timely manner from CAFTA-DR producers, and because no other fabric is substitutable for the fabric Intradeco seeks, we request that CITA add the specified fabric to the Annex 3.25 CAFTA-DR Short Supply List.
